Topics include the challenge of defining disability; the role of prejudice in conceptualizing rights-based laws; theories of equality as they relate to disability; the dissonance between social welfare and civil rights approaches to disability; and the use of international human rights and other laws to challenge institutionalization and advance community integration.

The collection concludes with works related to practice, "nuts and bolts" strategies that activists used to achieve passage of the landmark 1990 Americans with Disabilities Act, and a report of the ADA's practical impact on the lives of people with disabilities.

The editors are all associated with the Disability Rights Education and Defense Fund, a national law and policy center dedicated to protecting and advancing the civil rights of people with disabilities through legislation, litigation, advocacy, technical assistance, and education and training of attorneys, advocates, persons with disabilities, and parents of children with disabilities.
